THE RN-100 VISA MAY NOT BE GRANTED TO THE SAME PERSON MORE THAN ONCE IN A 6 MONTH PERIOD. IT WILL BE VALID FOR UP TO 90 DAYS AND CANNOT BE EXTENDED.
