 - MINIMUM OF 6 MONTHS REMAINING VALIDITY
 - AT LEAST ONE BLANK VISA PAGE
 - 2.) ONE (1) PASSPORT-TYPE PHOTOGRAPH (2x2", WHITE BACKGROUND)
 - 3.) [CLICK HERE](#) TO COMPLETE THE APPLICATION ONLINE AND PAY THE CONSULATE FEES ONLINE-**FAILURE TO DO SO IS SUBJECT TO CAUSE A 2 DAY DELAY IN PROCESSING THE APPLICATION. IF WE RECEIVE YOUR REQUEST AND THE APPLICATION WAS NOT COMPLETED ONLINE, VIP WILL TAKE CARE OF THIS STEP OF THE PROCESS FOR AN ADDITIONAL \$50.00 FEE USING THE INFORMATION PROVIDED ON THE HARD-COPY APPLICATION.**

THE NIGERIAN EMBASSY/CONSULATES IN THE U.S. REQUIRE THE ONLINE APPLICATION TO BE PREPAID USING ONLY APPLICANT'S OWN CREDIT CARD WHERE THE NAME OF THE CARD HOLDER (*AND THE BILLING ADDRESS*) MATCHES THE NAME ON THE APPLICATION. 

Once paid, print out the form and mail to the Embassy with a PROCESSING FEE of \$20.00 in money order made out to the Embassy of Nigeria. If expedited service is required, an additional fee of \$65.00 in money order made out to the Nigerian Embassy should be attached. Please attach original passport, colored passport photo showing full face on white background, letter of invitation from Nigeria and return prepaid Fedex, DHL, UPS, or Express mail, if applying by mail, **DO NOT ATTACH ENVELOPE AND STAMP**, your application will not be mailed back with that.

REQUIREMENTS FOR CHILDREN UNDER SIXTEEN:

Copy of birth certificate of child, 1 passport photograph, signed letter of consent by both parents and copies of the parents' passports (bio-data page) or valid ID **MUST** accompany the application.
