## TURKEY VISAS (ALL)

ALL U.S. PASSPORT HOLDERS ARE REQUIRED TO OBTAIN A VISA PRIOR TO TRAVELING TO TURKEY. APPLICANTS CAN EITHER OBTAIN AN E-VISA, OR A STICKER VISA IN THEIR PASSPORT. IF APPLYING FOR A STICKER VISA, THE TRAVELER WILL BE REQUIRED TO ABIDE BY JURISDICTIONS, AND TO APPLY DIRECTLY THROUGH THE CONSULATE ASSIGNED TO THE APPLICANT'S STATE OF RESIDENCE. AT THIS TIME, ALL APPLICANTS WILL BE REQUIRED TO MAKE A PERSONAL APPEARANCE AT THE CONSULATE IN ORDER TO OBTAIN A VISA.

**THIRD-PARTY SERVICES ARE NOT CURRENTLY PERMITTED TO ASSIST APPLICANTS WITH SUBMISSION OF APPLICATIONS FOR STICKER VISAS.**
