Visa Requirements

General Information:

The Consulate General of Venezuela in Houston, will process all visas applications submitted by residents of its jurisdiction: Texas, Oklahoma, Kansas and New Mexico. Residents of other jurisdictions should go to the appropriate Consulate.

General Requirements:

For the introduction of an application for any kind of visa the following is requested:

- A Passport that has at least 6 months of validity left at the time of your visa request
 - Two recent front view color photographs, 2 x 2 size.
 - Fill a Visa Application
 - Pay the applicable consular fees by means of a Money Order made to the name of the CONSULATE OF VENEZUELA (Tourist and Transit Visas U.S \$ 30; all other types of Visas U.S. \$ 60)
 - Fulfill the particular requirements for the pertinent type of visa

Business Visitor

Issued to non-immigrant traders, executives, representatives of enterprises or industries and micro entrepreneurs who enter the country to carry out activities and/or transactions related to trade, mercantile, financial or other lucrative activities in connection with their business.

Requirements:

- Visa application addressed to the Consulate General of Venezuela by the applicant himself or the enterprise responsible for the applicant's travel to Venezuela. The application shall indicate the purpose of the travel and the address of the enterprise or person to be contacted in Venezuela.
- Any of the following documents will be requested: mercantile or commercial registry number or a letter issued by the pertinent chamber or association of commerce or industry.
- If the applicant is the owner of the company or enterprise, he or she shall show documents that prove this condition.
- Resident Card or U.S. Visa (original and copy). (Not applicable to holders of US Tourist Visa).
- Police Record
- Travel Itinerary

Note: A work permit to do business in the country is granted for one (1) year with multiple entries. On each entry, the bearer of this visa may stay in the country for a period of up to one hundred and eighty (180) days. The stay in the country may not be extended beyond this period of time.
