URGENT NOTICE

INDIA VISAS IMPACTED BY CORONAVIRUS

AS A RESULT OF THE ONGOING CORONAVIRUS EPIDEMIC, THE INDIA EMBASSY & CONSULATES HAVE ISSUED THE FOLLOWING STATEMENTS REGARDING THE STATUS OF ALL CURRENT STICKER VISA & E-VISA HOLDERS:

"ALL REGULAR(STICKER) VISAS/E-VISA (INCLUDING VoA FOR JAPAN, AND SOUTH KOREA) GRANTED TO THE NATIONALS OF ITALY, IRAN, SOUTH KOREA, JAPAN, AND ISSUED ON/BEFORE MARCH 3RD, 2020 AND WHO HAVE NOT YET ENTERED INDIA, STAND SUSPENDED WITH IMMEDIATE EFFECT.

REGULAR (STICKER) VISAS/E-VISAS GRANTED TO THE NATIONALS OF PEOPLE'S REPUBLIC OF CHINA, ISSUED ON/BEFORE FEBRUARY 5TH, 2020 WERE SUSPENDED EARLIER. IT SHALL REMAIN IN FORCE.

REGULAR (STICKER) VISAS/E-VISAS GRANTED TO ALL FOREIGN NATIONAL WHO HAVE TRAVELLED TO PEOPLE'S REPUBLIC OF CHINA, IRAN, ITALY, SOUTH KOREA, AND JAPAN ON/AFTER FEBRUARY 1ST, 2020 AND WHO HAVE NOT YET ENTERED INDIA STAND SUSPENDED WITH IMMEDIATE EFFECT.

THOSE REQUIRING TO TRAVEL TO INDIA UNDER COMPELLING CIRCUMSTANCES MAY APPLY FOR A FRESH VISA AT THE NEAREST INDIA EMBASSY OR CONSULATE.

PASSENGERS OF ALL INTERNATIONAL FLIGHTS ENTERING INTO INDIA FROM ANY PORT ARE REQUIRED TO FURNISH DULY-FILLED SELF-DECLARATION FORM (INCLUDING PERSONAL PARTICULARS (I.E. - PHONE NUMBER & ADDRESS IN INDIA) AND TRAVEL HISTORY TO HEALTH OFFICIALS AND IMMIGRATION OFFICIALS AT ALL PORTS.

PASSENGERS (FOREIGN AND INDIAN) OTHER THAN THOSE RESTRICTED, ARRIVING DIRECTLY OR INDIRECTLY FROM CHINA, SOUTH KOREA, JAPAN, IRAN, ITALY, HONG KONG, MACAU, VIETNAM, MALAYSIA, INDONESIA, NEPAL, THAILAND, SINGAPORE, AND TAIWAN MUST UNDERGO MEDICAL SCREENING AT PORT OF ENTRY.

INDIAN CITIZENS ARE ADVISED TO REFRAIN FROM TRAVEL TO CHINA, IRAN, REPUBLIC OF KOREA, ITALY, AND ARE ADVISED TO AVOID ANY NON-ESSENTIAL TRAVEL TO OTHER COVID-19 AFFECTED COUNTRIES."

AS NEW INFORMATION IS MADE AVAILABLE FOR THIS, AND ANY OTHER COUNTRY AFFECTED BY TRAVEL AND HEALTH ADVISORIES, WE WILL BE SURE TO UPDATE THOSE IMPACTED.
