The Nigeria Consulate in New York is now able to process visas for travel to their country.

The Nigeria consulate is only open one day a week on Wednesdays. So we ask that if you do require a Nigeria visa to be submitted on your behalf that you have your documents arrive to our office by Monday of each week, so that we can prepare accordingly, pay the online fee's associated with the visa, and ship to the visa department to arrive on Wednesday morning.

The processing time is currently averaging between 5 and 7 business days, and below is the list of categories that we can process for the 5-7 day turnaround.

1. Temporary work permits
2. Business visas
3. Tourism visas
4. STR visas (20-25 business days to process)

If expedited service is required, an additional fee of \$65.00 in money order made out to the Nigerian Embassy should be attached. Please attach original passport, colored passport photo showing full face on white background, letter of invitation from Nigeria and return prepaid Fedex, DHL, UPS, or Express mail, if applying by mail, DO NOT ATTACH ENVELOPE AND STAMP, your application will not be mailed back with that.
