

<u>VALIDITY</u>: BUSINESS E-VISAS ARE VALID FOR MULTIPLE ENTRY UP TO 365 DAYS FROM DATE OF ISSUE, WHILE TOURIST E-VISAS ARE VALID FOR UP TO FIVE (5) YEARS. THE ONE AND FIVE YEAR TOURIST E-VISA ALLOWS FOR A STAY UP TO 180 DAYS PER CALENDAR YEAR, WHILE 30-DAY E-VISAS ONLY PERMIT A STAY OF UP TO 30 DAYS. IF YOU PREFER HAVING THE VISA ISSUED ON A PAGE IN YOUR PASSPORT, PLEASE CONTACT OUR OFFICE FOR THE APPROPRIATE INSTRUCTIONS.

SPECIAL NOTES:

- DOCUMENTS CAN BE SENT TO OUR OFFICE EITHER ELECTRONICALLY (INFO@VIPPASSPORTS.COM) OR BY SHIPPING
