ATTENTION

All travelers who wish to apply for a Mozambique visa must submit all of their documentation to our office in original format. Once we receive your documentation, we will scan everything to the Embassy of Mozambique. The visa officer will then forward the entire request to the immigration office in Mozambique so they can review the documentation and advise the Embassy in the USA if you have been approved to have a visa placed inside of your passport. This process will take 1-2 weeks for the immigration officer in Mozambique to review. Once the process has been reviewed and finalized and the approval has been issued, we will then have to forward all of the original documentation to the Embassy in Washington D.C. via FedEx to have the visa placed inside of the passport where the processing time for this to happen will be an additional 5-10 business days on the regular process or 3-5 business days on the rush process.
