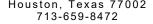

MOZAMBIQUE WORK/RESIDENCE VISA

- 3.) ONE (1) COMPLETED APPLICATION
- 4.) **COMPANY LETTER OF GUARANTEE** (IF AVAILABLE
- 5.) WORK CONTRACT FROM THE COMPANY IN MOZAMBIQUE (COPY)
- 6.) ALVARA BUSINESS PERMIT (COPY)
- 7.) COPY OF THE MOZAMBICAN ID OF THE EMPLOYER
- 8.) CLEAN BILL OF HEALTH (3 MONTHS VALIDITY)
- 9.) LETTER FROM THE MINISTRY OF LABOR IN MOZAMBIQUE (COPY)
- **10.) YELLOW FEVER VACCINATION CARD** ONLY REQUIRED IF YOU HAVE BEEN TO A YELLOW FEVER ENDEMIC COUNTRY.
- 11.) LEGALIZED POLICE CLEARANCE LETTER (3 MONTHS VALIDITY) THIS IS A 3-4 STEP PROCESS AND WE CAN HELP WITH THIS PROCESS, PLEASE CONTACT OUR OFFICE TO GET THE INSTRUCTIONS.
