- 3.) ONE (1) COMPANY LETTER OF GUARANTEE IF AVAILABLE (BUSINESS ONLY)
- 4.) **COPY OF ROUND-TRIP TRAVEL ITINERARY** IF AVAILABLE
- 5.) CONSULATE FEE:
 - \$ 60.56 THREE MONTH SINGLE ENTRY
 - \$ 88.73 THREE MONTH DOUBLE ENTRY
 - \$169.02 SIX MONTH MULTIPLE ENTRY
 - \$159.16 FIVE YEAR MULTIPLE ENTRY
