

#### **QATAR BUSINESS VISA**

PLEASE SUBMIT THE FOLLOWING REQUIREMENTS

#### 1.) SIGNED U.S. PASSPORT

- MUST HAVE AT LEAST 1 BLANK VISA PAGE
- MUST HAVE MINIMUM OF 6 MONTHS BEYOND INTENDED STAY IN-COUNTRY
- 2.) TWO (2) RECENT PASSPORT-SIZE PHOTOGRAPHS (2x2)
- 3.) ONE (1) COMPLETED TYPED APPLICATION FORM
- **4.)** <u>COMPANY LETTER OF GUARANTEE</u> (IF YOU ARE REQUESTING A MULTIPLE ENTRY VISA BE SURE THE COMPANY LETTER REQUESTS ONE ACCORDINGLY)
- 5.) COPY OF YOUR TRAVEL ITINERARY
- 6.) CONSULATE FEE:

**VALIDITY**: THE MULTIPLE ENTRY VISAS ARE USUALLY ISSUED FOR VALIDITY UP TO ONE YEAR, AND ALLOWS THE TRAVELER TO STAY UP TO 180 DAYS PER VISIT. THE LENGTH OF VALIDITY AND THE LENGTH OF STAY IS DETERMINED BY THE VISA OFFICER ON A CASE-BY-CASE EVALUATION.

ATTENTION: IF TRAVELING TO QATAR TO FULFILL ANY ASPECT ASSOCIATED WITH THE MILITARY, THE CONSULATE WILL BE REQUIRED TO GET AUTHORIZATION FROM THEIR MINISTRY OF FOREIGN AFFAIRS BEFORE THEY CAN ISSUE THE VISA. YOU CAN EXPECT THE PROCESS TO TAKE 2 TO 3 WEEKS, POSSIBLY LONGER, TO RECEIVE THE APPROVAL. THE CONSULATE RECOMMENDS THAT YOU DO NOT PURCHASE THE AIR LINE TICKETS UNTIL THE VISA HAS BEEN ISSUED AND THE PASSPORT IS IN-HAND.
