

The Chinese Consulates in **New York**, **San Francisco**, **Los Angeles**, and **Chicago** have recently updated their visa submission process.

Effective immediately:

- All visa requests under these jurisdictions must be completed and submitted through the new Chinese online visa portal.
- Applications must first undergo a **preliminary review** by a Visa Officer. This review process may take **3–5 days**.
- VIP Passport Services will manage the entire online submission process for you. However, you must complete the "TYPE ON SCREEN" application form included in your paperwork packet so that we have the necessary details to prepare your online application.
- Once the Visa Officer verifies and approves your application, we will then submit your documents in person to the Consulate.
 - Express service: 4 additional business days.
 - o **Regular service**: 6–7 additional business days.

For applications that fall under the jurisdiction of the Washington, D.C. Embassy:

- The online portal submission is not required.
- Instead, you (the customer) must complete the application directly using the link provided in your paperwork.
- Once completed, email us a copy along with the **Draft I.D. number** so we can review and proof your application before you mail your documents to our office.

This is a **new program implemented by the Chinese government**, and requirements may change at any time. Our office will continue to monitor updates and provide you with the most accurate and current information.





COPY OF THE INVITATION LETTER ATTENTION TO THE EMBASSY OR CONSULATE IN THE APPLICANT'S JURISDICTION (SEE PAGES 6 THROUGH 8 FOR MORE INFORMATION) MUST BE ISSUED BY THE CHINESE GOVERNMENT, COMPANY, CORPORATION AND/OR AUTHORIZED CHINESE AGENCY. THE VISA OFFICER MAY CONTACT THE CHINESE HOST TO VERIFY INFORMATION ON THE LETTER OF INVITATION, WHICH MAY DELAY THE PROCESS IF THE CONSULATE IS UNABLE TO REACH THE INVITING ORGANIZATION. IF THE INVITATION IS NOT PROVIDED BY THE OFFICIAL CHINESE GOVERNMENT, THE LETTER MUST INCLUDE THE FOLLOWING ITEMS:
 - ❖ PERSONAL INFORMATION OF THE APPLICANT INCLUDING FULL NAME, PASSPORT NUMBER, JOB TITLE, GENDER, AND DATE OF BIRTH.
 - ❖ INFORMATION CONCERNING THE APPLICANT'S VISIT TO CHINA INCLUDING THE PURPOSE OF THE VISIT, DATE OF ARRIVAL, DATE OF DEPARTURE, PLACES TO VISIT, RELATIONSHIP BETWEEN THE APPLICANT AND THE INVITER, AND WHO WILL BEAR THE COST OF THE APPLICANT'S ACCOMMODATIONS IN CHINA
 - ❖ INFORMATION OF THE INVITER INCLUDING THE NAME OF THE UNIT, PHONE NUMBER, ADDRESS, SEAL AND SIGNATURE OF THE LEGAL REPRESENTATIVE (IF THE COMPANY DOES NOT HAVE AN OFFICIAL SEAL PLACED ON THE INVITATION THE CONSULATE WILL WANT A COPY OF THE CHINESE COMPANY'S CERTIFICATE OF INCORPORATION OR ITS EQUIVALENT).
 - ❖ INFORMATION PROVIDED ON THE INVITATION REGARDING THE CITY OF THE INVITING COMPANY MUST CORRESPOND WITH THE ADDRESS OF THE HOTEL LISTED ON THE APPLICATION

- 15.) FORMER CHINA NATIONALS: BE SURE TO LIST THE CHINESE NAME IN SECTION 1.2 OF THE APPLICATION. APPLICANT MUST ALSO PROVIDE A COPY OF THE PREVIOUS CHINESE VISA THAT WAS ISSUED IN THE U.S. FIRST-TIME APPLICANTS WHOSE FORMER NATIONALITY WAS CHINESE, OR WHO WERE BORN IN CHINA (INCLUDING HONG KONG, MACAO AND TAIWAN), NEED TO SUBMIT THE ORIGINAL CHINESE PASSPORT PREVIOUSLY HELD. SUBMIT A COPY OF THE NATURALIZATION CERTIFICATE.

FORMER TAIWAN NATIONALS: IN SECTION 1.8 (PLACE OF BIRTH), PLEASE LIST "CHINA". PLEASE ALSO PROVIDE A COPY OF THE TAIWANESE PASSPORT. IF THE TAIWANESE PASSPORT PREVIOUSLY HELD IS NOT AVAILABLE, THE APPLICANT WILL NEED TO PROVIDE A COVER LETTER EXPLAINING THE CIRCUMSTANCES (THE CONSULATE HAS BEEN KNOWN TO ASK THAT THE APPLICANT COME IN PERSON FOR AN INTERVIEW). SUBMIT A COPY OF THE NATURALIZATION CERTIFICATE.

VALIDITY: THE CONSULATE WILL TYPICALLY ISSUE THE VISA VALID FOR UP TO 120 MONTHS THAT WILL ALLOW MULTIPLE ENTRIES FOR A STAY FROM 30 TO 60 DAYS ON EACH ENTRY. IF REQUESTING A STAY OF LONGER THAN 60 DAYS, THE CONSULATE WILL ISSUE THE VISA WITH A VALIDITY OF ONLY 12 MONTHS. THE VALIDITY, DURATION OF STAY, AND NUMBER OF ENTRIES OF THE VISA IS ISSUED AT THE DISCRETION OF THE CONSULAR OFFICERS, WHOSE DECISIONS ARE BASED ON THE LAWS AND REGULATIONS OF CHINA. THE CONSULAR OFFICERS HAVE THE AUTHORITY TO REFUSE ANY VISA APPLICATIONS INCONSISTENT WITH CHINESE LAWS AND REGULATIONS, OR REVOKE ISSUED VISAS.
