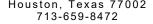

NIGERIA TOURIST VISA

PLEASE BE PREPARED TO SUBMIT THE FOLLOWING DOCUMENTS:

1.) SIGNED U.S. PASSPORT

- MINIMUM OF 6 MONTHS REMAINING VALIDITY
- AT LEAST TWO BLANK VISA PAGES
- MUST BE <u>SIGNED</u>
- 2.) ONE (1) RECENT PASSPORT-TYPE PHOTO (2x2", WHITE BACKGROUND)
- 2.) ONE (1) SIGNED APPLICATION FORM SEE BELOW PAGES
- 3.) COPY OF ROUND TRIP ITINERARY
- **4.)** NOTARIZED LETTER OF INTENT MUST BE ADDRESSED TO VISA OFFICER EXPLAINING THE NATURE OF YOUR VISIT, AND REQUEST A SINGLE OR MULTIPLE ENTRY VISA. LETTER MUST BE ORIGINAL, AND NOTARIZED.
- 5.) COPY OF INVITATION FROM HOST IN NIGERIA THE VISA OFFICER WILL ALSO WANT TO SEE A COPY OF HOST'S PASSPORT AND NIGERIA VISA (OR A COPY OF THEIR NIGERIAN PASSPORT). THIS DOCUMENT WAS PREVIOUSLY NOT REQUIRED FOR APPLICANTS BORN IN NIGERIA, BUT THE EMBASSY/CONSULATE NOW REQUIRES ALL APPLICANTS SUBMIT THIS DOCUMENT
- **6.)** CONFIRMED HOTEL CONFIRMATION (IF THE APPLICANT IS NOT STAYING WITH THE HOST) THIS DOCUMENT IS NOT REQUIRED FOR APPLICANT'S BORN IN NIGERIA.
- 7.) COPY OF CURRENT BANK STATEMENT WILL NEED TO HAVE A BALANCE OF \$1000.00 OR MORE AND MUST SHOW ACTIVITY. THIS DOCUMENT WAS PREVIOUSLY NOT REQUIRED FOR APPLICANTS BORN IN NIGERIA, BUT THE EMBASSY/CONSULATE NOW REQUIRES ALL APPLICANTS SUBMIT THIS DOCUMENT
- 8.) CONSULATE FEE: \$255.00 (NON-REFUNDABLE)
