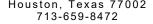

PLEASE BE PREPARED TO SUBMIT THE FOLLOWING DOCUMENTS:

- 1.) SIGNED U.S. PASSPORT
 - MINIMUM OF 6 MONTHS REMAINING VALIDITY
 - AT LEAST 2 BLANK VISA PAGES
 - MUST BE SIGNED
- 2.) ONE (1) RECENT PASSPORT-TYPE PHOTO (2x2 WITH WHITE BACKGROUND)
- 3.) ONE (1) SIGNED VISA APPLICATION FORM SEE BELOW PAGES
- 4.) <u>COPY OF IMMIGRATION APPROVAL</u> CLEAR COPY OF NIGERIA TELECOMMUNICATIONS LETTER FROM ABUJA, ALONG WITH A LETTER OF INTRODUCTION FROM THE HOST ORGANIZATION IN NIGERIA. WILL NEED A CLEAR COPY OF THE PASSPORT OF THE PERSON WHO SIGNED THE PRE APPROVAL LETTER
- 5.) **COMPANY LETTER OF GUARANTEE** FROM THE U.S. COMPANY **SEE NEXT PAGES**
- 6.) ONE (1) COPY OF THE CERTIFICATE OF INCORPORATION FROM THE NIGERIAN COMPANY

<u>VALIDITY</u>: TEMPORARY WORK PERMIT VISAS ARE VALID FOR ONE ENTRY WITH IN NINETY (90) DAYS FROM THE DATE OF ISSUE. UPON ARRIVAL YOU WILL BE ALLOWED TO STAY UP TO 60 TO 90 DAYS DEPENDING ON WHAT WAS REQUESTED IN THE ABUJA LETTER AND AS REFLECTED ON THE VISA. THE APPLICATION WILL BE REQUIRED TO BE PROCESSED AT THE EMBASSY OR CONSULATE AS LISTED ON THE ABUJA LETTER.
