ATTENTION

The Chinese Embassy and Consulates have recently updated their visa submission process.

Effective immediately:

- All visa requests must be completed and submitted through the **new Chinese online visa portal**.
- Applications must first undergo a **preliminary review** by a Visa Officer. This review process may take **3–5 days**.
- **VIP Passport Services** will manage the entire online submission process for you. However, you must complete the **visa application form** included in your paperwork packet so that we have the necessary details to prepare your online application.
- Once the Visa Officer verifies and approves your application, we will then submit your documents in person to the Embassy/Consulate.
 - **Express service:** 4 additional business days.
 - **Regular service:** 6–7 additional business days.

This is a **new program implemented by the Chinese government**, and requirements may change at any time. Our office will continue to monitor updates and provide you with the most accurate and current information.
