U.S. PASSPORT HOLDER

A VISA IS NOT REQUIRED FOR A U.S. CITIZEN TRAVELING TO THE PHILIPPINES FOR THE PURPOSE OF BUSINESS OR TOURISM IF YOUR STAY WILL BE LESS THAN 30 DAYS. FOR STAYS OF 30 DAYS OR LONGER, PLEASE SUBMIT THE FOLLOWING INFORMATION FOR A VISA:

- 1.) U.S. PASSPORT (MINIMUM OF 6 MONTH VALIDITY)**
- 2.) ONE (1) PASSPORT - TYPE PHOTOGRAPH (2x2) – MUST BE LESS THAN SIX MONTHS OLD**
